The Mid-Atlantic Great Dane Rescue League, Inc. (MAGDRL) was organized in 1979 to serve the seven states of the Mid-Atlantic region. The organization is a DC corporation and has a charitable tax-exemption under 501(c)3 of the Internal Revenue Code.

MAGDRL is staffed completely by volunteers. Like all humane groups, MAGDRL is in the unique position of helping both humans and pets. In our case, the pets are Great Danes and mixed Dane dogs, and the people are those who have or want the companionship of the breed or, often, just dogs in general.

MAGDRL helps people to:

- •Determine the right breed of dog for their lifestyle
- •Find healthy and companionable Danes that fit their circumstances
- •Find loving replacement homes for Danes they can no longer keep
- •Become knowledgeable about the care and training of their Great Danes
- •Resolve their Danes physical/behavioral problem
- •Overcome the grief at the loss of their loved pet
- •Stretch their tax dollar by assuming the Dane burden from public shelters

MAGDRL helps Danes:

•By providing for the rescue and care of those who have been abandoned, neglected, and/or abused by their previous owners

•We spay/neuter and provide medical treatment as necessary to return the Dane back to good health

•We supply training/socialization to ensure their adaptability to new, good homes

•We work to place rescue Danes to people who provide secure, loving, and healthy homes

Rescue In Need Meet Regina



Regina is a pretty blue female Dane with natural ears who is approximately 11 months old. She came from a shelter where she was found as a stray. They detected a heart murmur and thought she would do best in rescue where she could receive the care she may need to address her heart issue. Regina does indeed have a heart issue and has been diagnosed with congenital heart disease, specifically, severe pulmonic valvular stenosis (PS) with significant right ventricular hypertrophy. She does not have any arrythmias or congestive heart failure at this time. She is a candidate for pulmonic valve balloon valuloplasty and we will be researching for a cardiac surgeon to do this for her. Right now Regina is a normal happy go lucky sweet Great Dane puppy who loves to romp and play. She is currently being fostered with 3 other Danes (1) male/2 females) and a few cats and gets along with them all. She is crate trained, housebroken and loves everyone she meets. Regina is very smart and pretty mellow for her age although she can get the zoomies like the best of them. She has learned "sit" and "wait", "down" and "kennel". She is currently on medical hold until her cardiac issue can be treated. Although it will not be a cure, we are hoping it can extend her life for a few years. Regina came to MAGDRL in March 2020

MAGDRL is sustained by 236 volunteers in our six Chapters. All of the volunteers from president, to foster parents, to those who perform home visits and Dane evaluations — and much more — donate their time to help the Great Danes in our rescue.

No one in MAGDRL receives financial compensation, yet all are happy to give of themselves and donate their time. Our volunteers come from an array of professions and have a diverse field of knowledge. There are no skill requirements for volunteers and almost every talent can be put to good use. Some volunteers do paperwork and some raise funds, others edit or write articles for our Rescuers Record newsletter. This quarterly magazine is filled with volunteer activities, health and training tips and articles, and is geared toward improving the lives of Great Danes and their owners.

Each year volunteers make a nominal donation for membership which qualifies them to vote in our annual Board of Directors election, provides insurance coverage, and gives them access to volunteer training and our newsletter.

Volunteer Dues this year were reduced from 40 family/25 individual to 15 family/10 individual.

Although no two volunteers are alike, there is one thing that binds us together: Our love and compassion for the Gentle Giants in our care. Our Great Danes may be seen at meet and greets events, fundraisers, local festivals, Pet Expos and in many other venues. MAGDRL volunteers hold their Dane's lead as they educate the public about life with Danes and general dog care.

Without the countless hours donated by our volunteers who are our friends, neighbors, and other Dane owners, the public might not get a complete picture of life with a Great Dane. No matter what each volunteer contributes, each and every one is vital to the success of this organization. We LOVE our volunteers, they are the backbone of MAGDRL.

More 2019 Statistics

- The number of inquiries to surrender a Dane has decreased slightly in 2019. There were 539 inquiries in 2018 compared to 551 in 2018 representing a decrease of 2.2%.
- The number of Danes adopted in 2019 was 96 which is up by 38 while the number of Danes in rescue at the end of 2019 is 39 which id down by 26. The average number of days in rescue has increased this year to 151 compared to 120 days in 2018. This is due to some Danes that have been in rescue for many years that had been adopted or died this year.
- The ages of 1-3 years of age remains the most common years that a Dane is being surrendered or considered to surrender followed by ages of 3-5 years.
- The top reason for wanting to giveup a Dane is aggression with people and animals and remains high followed by "Abuse/Neglect/Seizure", "Cannot Handle" and "Owner Medical Problems"
